The Organization's proprietary model re-engineers fieldwork for the digital era, allowing it to complete these transfers securely, efficiently and transparently. Using the latest technology at every step, GiveDirectly locates recipients, integrates them into electronic payments networks, and monitors transfers end-to-end. The Organization charges donors the full cost of delivering this service and nothing more. Since 2009, GiveDirectly has reached approximately 5,000 recipients or 25,000 extremely poor individuals in Kenya and Uganda.
